- Created the new Office of Student Success to improve retention and graduation rates; exercised extensive interpersonal communications skills to unite, anchor, and support multiple student facing divisions during the turbulent Covid-19 semesters, which included hiring and terminating employees, supervising workers both remotely and on-campus, and managing through intense resource constraints and budget reductions.
- Improved on-time graduation rates to highest ever for Pace University. Reducing the gap between high-risk students and general population students by 2% points and increasing overall retention by 5.5% (underrepresented student retention improved 3-10% points).

- Serving as the lead Provost Office administrator for all Registrar issues related to the Pace Works Executive Steering Committee (VP administrators and above) during our multi-year comprehensive student facing systems redesign.
- Serving as the lead administrator for resolving all student academic problems that rise to the Provost and President's Offices, resolving conflicts with faculty, and challenges with the Registrar, Student Billing, Financial Aid, Veterans Affairs and Advising.
- Serving as the Title IX Provost's Office Appeals Officer.
- Negotiated consensus out of a highly contentious reorganizing of the University Libraries. We
  restructured two University Libraries into one library system, led by one University Librarian,
  where we achieved a balance between centralized and campus specific functions.
- Managed a similar process in the transformation of our multi-campus tutoring centers into a
  Learning Commons, with centralized leadership, common services across two campuses, the
  expansion to on-line academic supports, the integration of math and writing centers, and the
  addition of the science learning center.
- Centralized 35 academic advisors across five schools under a new Associate Dean for Advising
  focused on transforming academic advising processes to improve retention, based upon a
  collaborative plan developed by a university-wide Presidential Task Force on Advising
  (Centralized Processes/Expanded Professional Development/Created Greater Equity Across
  Positions/Coordinated Summer Melt Initiative).
- Supervising (and negotiating) budgets of over \$11.5 million dollars, managing significant budget reductions and reallocations during Covid-19, working collaboratively with the Assistant Vice President-Academic Finance, for six divisions, the University Library, and the Center for Community Action and Research.
- Provost Office senior lead for all Registrar related functions for PaceWorks, a university-side systems re-engineering of all student related processes and workflows.
- Supervising the Center for Community Action and Research for two years, which oversees civic engagement courses and community work for the University.
- Guiding and supporting multiple collaborative student retention initiatives, such as our annual Student Success Conference, recruitment and engagement events with parents and students, and administering T-Bone, our student success Chatbot.
- Improving systems and processes, including building more transparent pathways for students through the acquisition of a new academic catalog and the creation of new major maps, and clearing challenges and promoting solutions through collaboration across academic and non-academic departments. For example, moving all student success divisions to a single student academic and attendance alert system for documenting and addressing concerns. We have increased faculty utilization of this system by nearly 50%.
- Convening committees of faculty and staff to identify and resolve challenges in our academic and student support areas, including the Math Task Force, the Academic Scheduling Advisory Committee, the OnTrack Advisory Committee, the Associate Dean's Committee, the Westchester Task Force, and the Finish in Four committee, all aimed at improving processes for increased retention and timely graduation.
- Initiated Mosaic Medicine, a minority male athletes in medicine program, at Pace with our Arts & Sciences Dean and faculty, our Athletics Director, Mt. Sinai Medical School, the Associated Medical Schools of New York, and the NCAA.
- Facilitated the first successful effort to build eSports at Pace, in collaboration with our Athletics Director. (Now an award winning and retention forward division at Pace).
- Conducting performance management evaluations for seven direct reports and one indirect report. Approving their subordinate staff performance evaluations.
- Worked with an alumna on a new \$5,0000 annual scholarship.
- Wrote three large grants (one federal and two regional), with one highly recommended and the other recommended for resubmission, for a total of over \$1.5 million dollars. I obtained one \$100,000 grant to support a LabTech program and another for \$32,000 to support undergraduate internships.

- Coordinated with the adjunct union and Human Resources to oversee and approve adjunct overages and assure compliance with the collective bargaining agreement and to mediate adjunct concerns.
- Analyzed faculty release time and stipend awards in an effort to improve faculty compensation equity and identify possible cost savings.
- Collaborated on building new degree programs and introduced new modalities, including new online degree programs, working with the Finance Office to build new Pro Forma applications, new budget systems, and new annual reports for all divisions- academic and nonacademic. Worked closely on NYS Program Applications.
- Worked closely with faculty on a number of collaborative governance issues, including the controversial transformation of our Challenges to Achievement program, an academic support program for academically vulnerable and underprepared students overseen by faculty. I convened a task force of faculty and staff and worked to collectively identify a more holistic and comprehensive tiered advising program to improve student retention among participants, taking this from a one-year to a four-year program that serves all students who evidence vulnerability at any point during their Pace tenure.
- Finalized a collaborative pre-medicine course of study with The Kings College for their high-achieving science students.
- Negotiated multiple dual admission agreements with area community colleges (three signed; four in process) and supporting the agreement with Bard Early College (national associate degree granting high school program) by supervising curricula mapping, negotiating between legal counsel offices across the colleges and universities, and establishing joint advising activities.
- Negotiated internally with the Pace Honors College on both campuses to participate in dual admission agreements with community colleges (and successfully hiring the Director for the Honors College-Pleasantville).
- Advocated for, and obtained, the expansion of \$25,000 annual scholarships for all transfer students with GPAs of 3.2 and above from our dual admission community college partners.
