Course Descriptions

- ¹ HSC100 is a required Health Science Major Core that can be taken as an elective for non-Majors. Ethical theories and principals are introduced and discussed in the context of key health care issues.
- ² HSC200 is a required Health Science Major core course that can be taken as an elective for non-Majors. This course provides an overview of global health challenges facing diverse populations worldwide.
- ³ HSC210 is a required Health Science Major Core that can be taken as an elective for non-Majors. This course offers a broad introduction to essential elements of health care policy in the United States.
- ⁴ HSC335 provides students with an understanding of how global health policy is designed, implemented and evaluated. Using case studies, students will learn to apply theories and principles of policymaking to the formulation of health policy in response to current global health problems.
- ⁵ HSC315 is a required Health Science course for students completing the Global Health Concentration and may be taken as an elective by non-Majors. This course offers an introduction to theory and practice of innovation in healthcare technology and delivery.
- ⁶ HSC480 is a required Health Science course for students completing all Health Science concentrations. The course is not available as an elective by non-Majors and is intended to be taken in conjunction with an approved Health Science internship related to a degree concentration in Global Health and/or Health Policy and Advocacy. This course provides students with the skills to integrate the knowledge they have acquired during their Health Science training.
- ⁷ HSC420 introduces current issues and polices in health care and impact on the direct delivery of care in the United States. Students will examine the challenges of historical and future reforms to the health care sector, including examining the current payment structures, shifting to value over volume, and utilizing modern technologies in a heavily regulated industry.
